In August, 1976, a High-level Committee under the Chairmanship of the former Minister of State for Works and Housing was set up to consider the recommendations of the Burrey Committee. The high level Committee held three meetings but no final decision was taken.

Subsequently, it was decided to set up a Committee of Officers to make a verification of each of the properties listed in the report of the Burney Committee and to give its suggestions as to how far the recommendations of the Burney Committee in respect of each property may be implemented. Accordingly, a Committee was set up on 15th September, 1977 by the Ministry of Works and Housing.

The Committee held six meetings in which, amongst others, the concerned officers of the Delhi Development Authority and the Delhi Wakf Board were also invited from time to time to assist in its task. As one member of the Committee proceeded on foreign assignment, the Committee has been reconstituted on 25th July, 1978. The report of the Committee is awaited.

# Formation of Wakf Boards in States

These provisiors contain the necessary guidelines and the Central Government has no power under the Act to issue any additional guidelines.
