## Suggestion regarding a separate UG<1 for South

- 1518. SHRI T. ANJIAH: Will the Minister of EDUCATION. SOCIAL WELFARE AND CULTURE he pleased to state:
- (a) whether Government's attention has been drawn to a Statement reported to have been made by the Education Minister of Andhra Pradesh suggesting the setting up of a separate University Grants Commission for the South; and
- (b) if so, what is the Central Government's reaction thereto?

The State Education Minister sug gested that the request deserved consideration and necessary exami nation. The State Government has, however, not taken any action in the matter so far.

## Distribution of levy sugar in villages

1519. SHRI V. P. MUNU-SAMY: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state whether it is a fact that the levy sugar is distributed in villages through fair price • shops; if so, what is the quantity of sugar issued per unit?

THE MINISTER OF STATE IN THE MINISTRY OF AGRI-

**CULTURE** AND IRRIGATION (SHRI BHANU PRATAP SINGH): In accordance with the decision taken on 27th October. 1977, the Statewise monthly levy sugar quotas were refixed from December, 1977) with reference to the projec-

ted population as on 1-4-1978 ensuring 425 grams of monthly per capita availability. All the State Governments were also advised to gear up the distribution machinery to ensure distribution at the enhanced level and also to treat the ruial and urban population in a similar manner for the purpose of distribution of levy sugar. 23 State Governments/Urion Territory ministrations have informed that similar scale for distribution of levy sugar for urban and rural population has been introduced. However, depending upon the number of ration card units, the scale of distribution would differ from State to State.

## Nursery education in the educational programmes of government

- (a) whether it is a fact that nursery education does not find any place in the educational policy and programmes formulated by the Central and the State Governments;

- (c) if so, what are the reasons therefor; and
- (d) what steps Government are taking to give due place to nursery education in Government's educational policy?
