**Provident Fund dues of the workmen of the Pulgaon Textile Mills in Wardha district of Maharashtra**

(a) what is the amount of provident fund dues of workers of the Pulgaon Textile Mills in the Wardha district of Maharashtra which has not been deposited by the previous management of the mills; and

(b) what steps the National Textile Corporation has taken to pay these dues specially when the Mill is making profits?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND PARLIAMENTARY AFFAIRS (DR. RAM KRIPAL SINHA): The Employees' Provident Fund Authorities have intimated as follows:

(a) Pulgaon Cotton Mills, Pulgaon in Wardha District is an establishment exempted under section 17(1)

(a) of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952. An amount of Rs. 32.57 lakhs has not been transferred by the previous employer to the Board of Trustees of the Mills.

(b) The Mill has been taken over for a period of five years by the Maharashtra State Textile Corporation with effect from 27th November, 1970. The Corporation has been appointed as the authorised persons under the Industries (Development and Regulation) Act, 1951 (65 of 1951). The question of payment of dues by the National Textile Corporation does not arise.

**Proposal from the Central African countries to postpone the Havana meeting**

1724. SHRI B. SATYANARAYAN REDDY: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether it is a fact that Egypt, Cambodia, Somalia, Morocco and the Central African countries have suggested in Belgrade that the Havana meeting of the non-aligned countries be postponed; and

(b) if so, what are the details in this regard?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI ATAL BIHARI VAJPAYEE): (a) Yes, Sir. Some countries including Egypt, Kampuchea, Somalia and Morocco had suggested at the Belgrade meeting of the Non-aligned Foreign Ministers that the decision regarding holding

the Summit of Heads of State | Government of the non-aligned countries in Havana next year be reconsidered.

(b) The Belgrade meeting of Foreign Ministers of non-aligned countries has endorsed the Cuban proposal to hold the Summit in Havana in September, 1979.
