the country have to take it seriously that the Government does not have adequate means to obtain information on the bases in the Indian Ocean? My second question is this. What is ihe Foreign Minister's assessment or perception of Chinese interest in the Indian Ocean? In view of the Chinese efforts to strengthen and modernise their armed forces including their navy and keeping in view the long-term implications of the question, is the Foreign Minister making any attempt to involve China in the dialogue to keep the Indian Ocean a demilitarised zone?

चीन को ग्रगर हिन्द महासागर के संबंध में जो वार्ता हो रही है उसमें शामिल किया जा सके तो बहुत ग्रन्छी बात होगी ; चीन हिन्द महासगर में भ्रधिकाधिक रूचि ले रहा है इस लिये उस का इस बार्ता में शामिल होना ग्रावश्यक है ।

Will the Minister of COMMUNICATIONS be pleased to state;

- (a) whether it is a fact that ₀f late there has heen a deterioration in the telephone services in Farrukhabad district of Uttar Pradesh;
- (b) whether it is also a fact that the Subdivisional exchanges in that district have a poor performance; and
- (c) if so, what steps Government propose t₀ take to remedy the situation?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI NARHARI PRASAD SUKHDEO SAI): (a)

- (to) Yes, Sir, as the performance is not satisfactory.
- (c) Efforts are made on a continuing basis to improve the services. The important steps that have been or are being taken are indicated in the statement being laid on the Table of the House

Statement

The following important steps have been or are being taken to improve the telecom, services in Farrukhabad district (UP) on a continuing basis:

Farrukhabad Exchange:

(a) Replacement of the existing 120 A.H. capacity battery by another battery of 450 A.H. has been planned.

- (to) Underground cable is being laid to reduce openwire local telephone lines to reduce faults.
- (c) Refitting of subscribers offices and distribution points (D.Ps.) is almost completed.

- (e) A 3-channel system has been installed between Farrukhabad and Kannauj. Further augmentation by having an 8-channel system has been planned.
- (f) Replacement of ACSR wire_s by eopper-weld wires in Farrukhabad-Mainpuri section is in progress to overcome the presentf ACSR wire theft and interruptions to communication.

SHRI CHADALAVADA VENKAT-RAO: It i_s a well known fact that whenever we ask something, the hon. Minister wiH say something and the correct information is r yver given by the Minister. Who does not know that the telephones are frequently going out of order? Still the hon. Minister says 'no'. I do not know in which part of the country the telephones are working properly and in perfect condition. I would like to know from the hon Minister-what is the difficulties ifr making the faulty system up-to-date and keeping it in a perfect condition for the subscribers.

SHRI BRIJ LAL VERMA: I have already stated the steps taken by the Government during this year. One < by one all these steps and the places where we are taking these steps have been narrated in this statement. It is no use repeating them. As the

equipment installed there was already faulty, I have this year taken all: these steps to improve the system.

SHBI CHADALAVADA VENKAT-RAO: What is the exact date by which all these facilities will be provided to the subscribers? What is the time factor involved?

MR. CHAIRMAN: Please resume your seat. Then the Minister yriH reply.

SHRI BRIJ LAL VERMA: If you read the whole statement and the various steps narrated therem, it will be very clear that I have taken very major step to overhaul the whole thing in order to improve the system.

SHRI KHURSHED ALAM KHAN: Sir, I am grateful to the honourable Minister for having placed on the Table of the House a very comprehensive statement indicating the steps that are proposed to be taken. But, Sir, may I remind the honourable Minister that when last year the same question was asked, the same answer was given with the same contents in the statement and most probably the same thing has been copied now? Now, in spite of all these things, may I tell the honourable Minister that the telephone services are ,horrib»e in this district which happens to be my district? And, if the honourable Minister has any doubt about it, I can give hirn my telephone number which is 64 and he can try to book a call today and he will not get it for the next one month. I can assure him of this. (Interrujp-tions).

MR. CHAIRMAN: please put your supplementary.

SHRI KHURSHED ALAM KHAN: Now, may I know from the honourable Minister why, if everything was all right as he has said—he has said that there is no deterioration in the service—so many steps are proposed to be taken? When will they be implemented and what is the progress now?

SHRI BRIJ LAL VERMA: Sir, I have already stated everything and I think the honourable Member has not read the statement. I hav* already stated /that with regard to the equi<pri>equi<pri>that was installed, during the previous years, their performance was not proper and so, at present, I am changing the whole thing, I am changing the whol» system, which will take its own time as it cannot be changed in one or two days. So, I am saying that we are doing all these things only with a view to improving the position.

MR. CHAIRMAN: Yes, Mr. Lokesh Chandra. I think this question ha« been discussed already. Why should you waste the time on this?... (Interruptions). Yes, Mr. Lokesh Chandra.
