THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a> and (b) No feed grains such as maize, rice, bran etc. are at present being made available to the Cooperative Sec. tor for manufacture of cattle and poultry feeds under the United Nations Food Assistance Programme or any other programme for promotion and-development of dairy and poultry farming in India.

However, under Project No. 348 viz. "Improvement of milk Supply through Balanced Feeding of Cattle and Milk Toning" 70,500 M.T. of maize/sorghum was made available for the preparation of balanced cattle feed by the World Food Programme of the United: Nations. Of this quantity 38,035 M.T. of maize/sorghum was supplied  $t_0$  the Cooperatives in Gujarat and 1,388 M.T. of maize/sorghum to the Cooperatives in U.P. The project was terminated on 31-3-1978.
