

(d) No, Sir. Selection Grade to T.G.T. and the Laboratory Assistants was given by the Management prior to the coming into force of the Act/ Rules *ibid*.

(e) The question of revision of seniority lists on the basis of separate and distinct legal entity of each school as per provisions of the Delhi School Education Act/Rules, 1973 is under consideration of the Management of Ramjas School. It is for the Management to finalise the seniority of each category of teachers, School-wise and thereafter send proposals for the grant of selection grade to the Education Directorate, Delhi Administration, Delhi for approval under the provisions of the Act and rules. In view of this the question of disparity does not arise.
