be shunted from one place to another. They should be given all the protection which is given to permanent workers-medical facilities and so on.

SHRI P. RAMACHANDRAN; Protection will be given; medical facilities will be given. But they are not prepared for a discussion unless they are made permanent. That is the question.

SHRI KALYAN ROY: They are prepared to discuss with the management at any time. (Interruptions).

SHRI N. P. CHENGALRAYA NAIDU: Sir, I put the question only in order t₀ draw the attention of the Government that many Ministers are not visiting the south.
