\*679. SHRIMATI PRATIMA BOSE: SHRIMATI PRATIBHA SINGH:

SHRIMATI SUSHILA SHANKAR ADIVAREKAR:

Will the Minister of ENERGY be pleased to state:

- (a) what are the norms laid down by the Badarpur Thermal Power Station in Delhi for disposal of its coal ash;
- (b) whether Government propose to direct the management of the Badarpur Thermal Power Station to supply a sizeable quantity of coal ash to co-operative sector so that the same could be made available to small and marginal farmers and economically weaker sections of the society; and
- (c) if so, what are the details in this regard?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): (a) The coal ash from Badarpur Thermal Power Station is disposed off in the form of wet slurry. There are no norms or conditions laid down in this regard.

(b) and (c) As the coal ash at Badarpur is disposed off in the form of wet slurry, it has no use and has no market. The question of supply of ash to co-operative sector, therefore, does not arise.
