Statement

Delhi Administration had launched a new scheme of moral education in all the Govenment and Government aided schools (middle and higher secondary) in the Union Territory of Delhi from 26th January 1978. Under this scheme the schools have been instructed to arrange, after the morning assembly and prayers, talks on various topics of ten to fifteen minutes' duration which would help in character building and inculcate a sense of patriotism and pride in national heritage amongst the dents. A list of books in Hindi and English written by different authors on topics of moral education along with some guidelines on the topics has been sent to all the schools by Delhi Administration.

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI JAGDAMBI PRASAD YADAV): (a) and (b) Yes, Sir. While renaming the hospitals the decisions have not been taken on the basis of local or regional considerations, the hospitals have been renamed to keep alive the memory of outstanding national personalities with distinguished records of public service.

Teesta Barrage Scheme

- (a) The Teesta Barrage Project is being implemented by the Government of West Bengal from out their plan resources and about Rs. 15 crores have been spent up to June, 1978.
- (b) Necessary infrastructure facilities are being created and work on the main canal has already started. The work on the barrages will be in full swing this year.
- (c) The project under implementation is planned to provide irrigation to about 3 lakh ha, in Darjeeling, Dinajpur, Malda and Jalpaiguri districts and will benefit about 55 lakhs of people.

(a) whether it is a fact that the facility enjoyed by the Central Government employees of getting allotment of Government accommodation made to them transferred in the name of their sons or daughters employed in Government service after retirements has been withdrawn; and

(b) if so, what are the reasons therefor?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY REHABILITATION (SHRI SINKAN-DAR BAKHT); (a) Yes Sir.

(b) The Staff side of the National Council (JCM) was pressing for the withdrawal of this concession, as this has led to senior employees with 20 to 25 years of service being denied Government accommodation employees with a few years of service get accommodation on retirement of their parents. The demand was considered reasonable and accepted.

Production of jute in the country

Will the Minister of AGRICUL-TURE AND IRRIGATION be pleased to state:

- (a) whether it is a fact that production of raw jute in the country has declined during the last ten years posing a danger to the export perfornance of the jute manufacturers in the country; and
- (b) if so, what remedial steps Government propose to take in this behalf?

THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) No, Sir. Although the production of jute in the country has fluctuated years, the overall rate οf growth has shown an increasing trend.

(b) Question does not arise. Howcomprehensive Centrally а Sponsored Scheme of Intensive Jute District Programme has been launched by Government of India to increase jute production in the country since 1972-73.
