- (a) whether it is a fact that the balconies in the first and second floor of the LIG DDA flats in Tamoor Nagar are defective; and
- (b) if so what steps Government have taken to rectify the defects?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT): (a) and (b) The Delhi Development Authority have reported that there are no structural defects in the balconies and that they are structurally safe. However, some haircracks had appeared due to normal deflection under load. These minor defects have been rectified to the satisfaction of the residents.
