Import of Cotton

- 356. SHRI GOVINDRAO RAM-CHANDRA MHAISEKAR: Will the Minister of INDUSTRY be pleased to state:
- (a) what is the import policy in regard to cotton; and
- (b) what are the quantities of cotton imported during 1977-78 and so far during 1978-79?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (KUMARI ABHA MAITI): (a) and (b) It is the policy of the Government not to import cotton in circumstances that would be detrimental to the interests of the indigenous cotton growers.

During the cotton season 1976-77 (September—August) about 8.18 lakh bales of cotton had been imported. During the current cotton season 1977-78 a spill over quantity of 2.07 lakh bales of cotton out of the quantity contracted during the previous year, had been received.
