per recommendations of an Experts Committee appointed by the Chairman of ex-Hindusthan Slsel Ltd. The •cost of re-building of the battery was its. 218.66 lakhs.

(c) Rebuilding was carried out by *M/s* Otto (India) Ltd.

to the affected areas, if necessary by i road, even if connected by Rail. In so far as demands of criunuers in Jammu & Kashmir are concerned, a quantity of 1434 tonnes was despatched by SAIL to the State during April-June 1978 as compared Io &S83 tu::nes during the whole of 19 < 7-73. It is expected that supplies to the Slate will be maintained at the level of last year.
