Setting up of an Aluminium Project in Gujarat

*123. SHRI ARVIND GANESH KULKARNI; SHRIMATI LEELA DAMODAR MENON: SHRIMATI USHI KHAN; SHRI GURUDEV GUPTA;

Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether Government propose to set up an aluminium project in Gujarat with the collaboration of the Hungarian Government; and
- (b) if so, what are the details in this regard?

THE MINISTER OF STEEL AND MINES (SHRI BIJU PATNAIK): (a) No, Sir. However the Gujarat Mineral Development Corporation Limited (GMDC) have recently concluded an agreement with Hungarians for commissioning a feasibility study for setting up an export-oriented alumina pant of 300,000 tonnes per annum capacity in Gujarat State.

(b) The details will be known only after the feasibility study is completed. The study is likely to be completed in the first quarter of 1979.
