## Change in th<sub>e</sub> concept of minimum wages

- 460. SHRI BHABANI CHARAN PA TT ANA YAK: Will the Minister of PARLIAMENTARY AFFAIRS AND LABOUR be pleased to state:
- (a) whether Government's attention has been drawn to the suggestions made at the Fifth Industrial Relations Conference recently held at New Delhi under the auspices of the Employer's Association for changing the entire concept of minimum wages, freezing of the wages at the present level and non-consideration ol bonus as deferred wages; and if so, what are the details thereof;
- (b) what  $i_s$  Government's reaction in this regard; and
- (c) what steps Government are taking to protect the labourers and workers from exploitation by the employers?

THE MINISTER OF PARLIAMENT-ARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA); (a)- In a background paper on wages, incomes and prices policy for the Fifth Industrial Relations Conference held under the auspices of the Employers Association, in New Delhi on 13-14 February, 1978, which seems to have been prepared in the context of the terms of reference of the Study Group on Wages, Incomes and Prices it was suggested that, coinciding with economic policies which the paper urged the Government to adopt to stabilize prices of bulk commodities which constitute the cost of living 708 RS—3.

index, DA might be abolished. It was also suggested that as an adjunct, if wage revision was at all necessary, the neutralisation percentages to meet the price rise must be decided by Government. While suggesting abolition of the present bonus scheme, the paper suggested a scheme of incentive, payments to be introduced wherever feasible.
