### Strikes/lockouts in industrial units

- 503. SHRI VENIGALLA SATYA-NARAYANA: Will the Minister of PARLIAMENTARY AFFAIRS AND LABOUR be pleased to state:
- (a) whether it is a lact that the total number of mandays lost due to strikes and lock-outs in industrial units during the last three years up tb March, 1978 was 2.5 millions; and
- (b) what are the names of the factories under the Central Government in which there have been strikes and lock-outs during that period?

THE MINISTER OF PARLIAMENT-ARY AFFAIRS AND LABOUR (SHRI J3AVINDRA VARMA); (a) According to the information received by the Labour Bureau, up to 18th May, 1978, the total mandays lost due to strikes 'nd lock-outs in industrial units during the first three months of 1978 was 2.5 million.

(b) The information is being collected.

### Statement made by the Chinese Vice-Premier regarding Chinese support to Pakistan on Kashmir

- (a) whether Government's attention has been drawn to the reported statement of the Chinese Vice-Premier regarding Chinese support to Pakistan on Kashmir; and
- (b) if so, what is the reaction of the Government of India thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI S. KUNDU)- (a) Yes, Sir.

(b) China has in the past made similar expressions of it<sub>3</sub> stand. On this occasion, the Chinese Ambassador was told that the State of Jammu and Kashmir is an integral part of India. It had acceded to India long ago and there could be no question of self-determination for a part of a country.

## Criticism of new price policy of steel by small units

- 505. SHRI VENIGALLA SATYA-NARAYANA: WiH the Minister of STEEL AND MINES be pleased fo state:
- (a) whether it is a fact that the new price policy with regard to the supply of steel to small scale units has been criticised by the small scale units; and
- (b) if so, what action Government have taken in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA); (a) and (b) Some of the representations received in connection with the recent price increase in steel with effect from 4th/5th June, 1978 have interalia referred to the possible adverse impact on small scale units. However, actually the competitive position of the small scale units vis-a-vis the large scale units (who used to take their material earlier in rake loads at JPC price) has improved now, firstly as the gap between the JPC price and stockyard price of various steel items has been narrowed down to Rs. 35/- per tonne with the revision of prices; and, secondly it haa also been decided to supply steel to small scale unit, through the Small Scale Industries Corporations at Rs. 40/- per tonne less than the stockyard prices.
