Voting in elections to State Legislative Assemblies by the Indian citizens living abroad

1954. SHRI F. M. KHAN: Will the Minister of LAW, JUSTICE AND COMPANY AFFAIRS be pleased to state:

- (a) whether it is a fact that Indian citizens living abroad cannot vote in elections to the State Legislative Assemblies in India; and
- (b) if so, whether Government propose to remove this anomaly?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI SHANTI BHUSHAN); (a) Indian Citizens living abroad except persons who are employed under the

government of India, in posts outside India, are not eligible to vote in elections to Parliament and State Legislatures in India.

(b) No such proposal is under consideration.

Remittances by foreign drug manufacturing companies

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) and (c) A statement furnishing the requisite information for the years 1974/1974-75, 1975/1975-76 and 1976/1976-77, in respect of foreign drug companies in the organised sector having direct foreign equity exceeding 40 per cent, is enclosed. (b) Repatriation of profits etc. is permitted in terms of relevant statutory/regulatory provisions applicable to all such foreign companies in all Sectors of industry.
