- (a) No narrow-gauge line has been converted into broad gauge during the last three years. However, construction of a broad gauge line from Nadiad to Modasa (105 Kms.) involving conversion of Nadiad to Kapadvanj narrow gauge line (44.64 Kms.) in Gujarat into broad gauge has been approved in the Budget for 1978-79 and the construction work has since been taken up.
- (b) A reconnaissance engineeringcum-traffic survey for the conversion of Rupsa-Talbandh narrow gauge line in Orissa into broad gauge and its extension up to Gorumahcisani/Chakulia

has been taken up during the current financial year.

Survey for Oil Exploration in Tapti River Basin
