Complaint_S of irregularity practiced by M/s. Pfizer

1940. SHRIMATI RAJINDER KAUR: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether it is a fact that some Members of Parliament addressed a letter, dated the 6th February, 1976, to the then Prime Minister alleging certain irregularities by M/s. Pfizer Limited; and
- (b) if so, what is the nature of the allegations and what action Government have taken in the matter?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) Yes. Sir.

- (b) The following two points were raised:—
 - (i) Consideration of the application of M/s. Pfizer for the manufacture of Doxycycline; and
 - (ii) Regularisation of their excess production of oxytetracycline beyond the licensed capacity.
