The Co-operative Societies would be exempted from these ceilings.

- (c) Five new cooking gas distributorships are proposed to be created by Indian Oil Corporation (IOC) only in the Union Territory of Delhi.
- (d) and (e). According to the guidelines issued by Government to all the public sector oil companies, the award of agencies for retail outlets, LPG (cooking gas) SKO/LDO is to be made as under:
  - (i) 25 per cent for persons belonging to Scheduled Castes/Scheduled Tribes;
- (ii) 2 per cent for physically handicapped persons; and
  - (iii) the balance on commercial considerations, preference being given to genuine Consumer Co-operative Societies and Agro-Industries Corporations.

# Sale of pesticides/insecticides by the Hindustan Insecticides Ltd.

Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to refer to the answer to Unstarred Question 1015 given in the Rajya Sabha on the 31st July, 1978 and state:

- (a) the name<sub>S</sub> of the pesticides/insecticides offered and supplied for sale/distribution by the Hindustan Insecticides Limited to the State Departments of Agriculture in North India;
- (b) the arrangement made by the Hindustan Insecticides Limited for distribution of its formulations through the co-operatives;
- (c) whether the Hindustan Insecticides Limited has appointed any cooperatives for the distribution of its newly formulated pesticides/insecticides, namely Endosulfan, Malathion, DDT etc. in the Northern States of Punjab, Haryana, U.P., Rajasthan, J&K and Delhi; and
- (d) if not, what are the reasons therefor and what steps Government propose to take to ensure due share to the co-operative sector in the distribution of these new formulations?

THE MINISTER OF PETROLEUM CHEMICALS AND FERTILIZERS H. N. BAHUGUNA): (SHRI and (b). Hindustan Insecticides Limited are currently supply three Agroposticides namely HILDIT 50 per cent WDP (DDT 50 per cent WDP), HIL-BEECH-50 per cent WDP (BHC 50 per cent WDP) and HILDAN 35 per cent EC (Endosuifan 35 per cent EC). They have offered all these pesticides to the Punjab State Agro Industries Corporation, Director of Agriculture, Haryana, Cooperative Supply Haryana State and marketing Federation and Rajasthan State Agro Industries Corporation. Demand for H.I.L., Agro pesticides in Himachal Pradesh and Jammu and Kashmir is negligible. No sales have been effected through private parties.

(c) and (d). H.I.L.'s distribution is on a non-exclusive basis, with preperence to State Agros. etc. H.I.L. have not appointed any Cooperative specifically as their distributors. The Agro-Industries Corporations are, however,

understood to be distributing H.I.L.'s Agro Pesticides through cooperative outlets in addition to their own and pother outlets in their respective States.
