Recovery of loans from the Cooperative Societies

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHEI BHANU PRATAP SINGH): (a) and (b) replies have so far been received from some States, viz., Andhra Pradesh, Gujarat, Karnataka, Madhya Pradesh, Nagaland, Orissa, Rajasthan and Tamil Nadu and the Union Territory of Goa Daman and Diu. The Chief Ministers of the States and the Union Territory have generally agreed with the views expressed in the demi-official letter addressed to them. They have indicated the steps being taken to recover co-operative dues. These include launching special drives for recovery, setting up of review committees for monitoring collection, linking credit with marketing, strengthening supervision in the cooperatives and check on utilisation. Some of the States have also indicated that incidence of natural calamities and crop failures had been an important reason for the level of overdues.
