SHRI R. NARASIMHA REDDY: May I know from the hon. Minister whether he has received any representation in this regard from the artisans of Lucknow? In reply to part (a), the Minister said: "No, Sir/' I would like to know whether he is aware that there was a big article in the 'Times of India' about this industry in which it was stated that this is •a traditional industry in which thousands of families have been employed and there is a big consternation that to mechanised units the licences have been given. I would like to know whether they have applied tor a licence and if so, what is the at^ttude of the Government in view of the fact that twenty thousand people are likely to go unemployed from their traditional occupation.

SHRI GEORGE FERNANDES: The question pertains to grant of licence to a set of mechanised carpet manufacturing units in Lucknow. The answer is that no licence to produce any mechanised carpets has been given to any enterprise in Lucknow. in the State of U.P., there are two mechanised units. One is Tafter Carpet and Woollen Industries, located in Sikandr-abad in the district of Bulands-hahr. They were granted industrial liceice in August, 1971. 12.00 Noon

The other is Modi Carpets which is located in Rai Bareli district. This was granted industrial licence in May 1976.

SHRI PILOO MODY: Why in Rae Bareli?

SHRI GEORGE FERNANDES: Other than these two there are no mechanised units in Uttar Pradesh. I have not seen the article to which the hon. Member has made a reference.

SHRI R. NARASIMHA REDD if: Will the hon. Minister assure the House that in future no licences for machanis-ed units in this traditional type of industry will be given?

SHRI GEORGE FERNANDES: I have already stated that we will not

be giving any licences for production of carpets in mechanised units unless they are meant for exports.

MR. CHAIRMAN: Question Hour is over.
