more selective, category 'B' JCOs are given preference over category 'C JCOs in the matter of retention. While category 'B' JCOs can be retained beyond 15 years when the strength of the force is even upto 100 per cent, category 'C JCOs (except attributable) can only be so retained when the strength is below 95 per cent.

This is effective from 18 May 1977.

Approximately 120 officers/JCOs are likely to be affected in 1978 due to this revision in the physical standards. As this constitutes a very small percentage, this will have very little effect on the morale of the troops.
