GEORGE FERNANDES: As SHRI I pointed out, Sir, if the Delhi Admi nistration had to go into the question of allocation of paper, it is because there was racketeering and malfunctioning in the existing system. So, the point that the hon. Member is trying to make, has been met by the Delhi Administration in the course of the decision that it took to see that Department of the Industries the Delhi Administration, the Sales Tax Department of the Delhi Administra tion together make investigations and find out whether the existing copy book manufacturers are, in fact, using that paper to produce copy books and exercise books and selling them also at a reasonable price. When they discovered that there was a lot of bungling, that there was a lot of racketeering, they set the matters right. And that seems to be now the cause of the complaint. That is issue which has been agitating certain people outside on which there has been an attack. This, Sir, is the size of the problem. But as I said, and I repeat, if there is any area where any specific complaint is made, I shall most certainly have it looked into. I am not trying to evade the responsibility of Ministry. my Sir, the allocation of paper is made by the Education Ministry and the State Governments then have a well-oiled system. Every Government State looks after the subsequent distribu tion etc. I agree that we take the responsibility if any specific matter is brought to our notice where the paper is misused. The hon. Member made another observation about some remarks that I made. I would sub mit that when the officials who are unable to defend themselves here are constantly attacked in perjurious terms-it is all right where there are specific charges—when there is constant use of perjurious terms, it is something which I personally am not able to appreciate, and I entirely agree with the hon. Member

- (b) if so, whether Government are aware that thousands of peonie engaged in carpet industry in Lucknow are likely to be rendered unemnloyed due to the mechanisation of the industry there?

THE MINISTER OF INDUS! RY (SHRI GEORGE FERNANDES): (3) No. Sir.

SHRI R. NARASIMHA REDDY: May I know from the hon. Minister whether he has received any representation in this regard from the artisans of Lucknow? In reply to part (a), the Minister said: "No, Sir/' I would like to know whether he is aware that there was a big article in the 'Times of India' about this industry in which it was stated that this is •a traditional industry in which thousands of families have been employed and there is a big consternation that to mechanised units the licences have been given. I would like to know whether they have applied tor a licence and if so, what is the at^ttude of the Government in view of the fact that twenty thousand people are likely to go unemployed from their traditional occupation.

SHRI GEORGE FERNANDES: The question pertains to grant of licence to a set of mechanised carpet manufacturing units in Lucknow. The answer is that no licence to produce any mechanised carpets has been given to any enterprise in Lucknow. in the State of U.P., there are two mechanised units. One is Tafter Carpet and Woollen Industries, located in Sikandr-abad in the district of Bulands-hahr. They were granted industrial liceice in August, 1971. 12.00 Noon

The other is Modi Carpets which is located in Rai Bareli district. This was granted industrial licence in May 1976.

SHRI PILOO MODY: Why in Rae Bareli?

SHRI GEORGE FERNANDES: Other than these two there are no mechanised units in Uttar Pradesh. I have not seen the article to which the hon. Member has made a reference.

SHRI R. NARASIMHA REDD if: Will the hon. Minister assure the House that in future no licences for machanis-ed units in this traditional type of industry will be given?

SHRI GEORGE FERNANDES: I have already stated that we will not

be giving any licences for production of carpets in mechanised units unless they are meant for exports.
