THE MINISTER OF FINANCE (SHRI H. M. PATEL): (a) No, Sir. The report is still under examination of the Government.

(b) No, Sir, but the Government proposes to consult the concerned interests before taking final decisions on the Report.

THE MINISTER  $\mathbf{OF}$ FINANCE (SHRI H. M. PATEL): (a) The Study Group on Wages, Incomes and Prices has recommended, inter alia, that, as part of overall incomes policy of curbing excessively high non-wage incomes, direct taxes should be extended to the agricultural sector which is largely outside the tax net at present. It has, however, not recommended imposition of a Central Farm Tax.

In addition, tourist facilities such as accommodation, transport, etc. is provided by the public and private sectors. A statement giving a list of some of these places which have been developed in the interests of cultural tourism, wildlife tourism. and sports tourism (winter sports and beach resorts) is laid on Table of the House.

As regards the development of centres during 1973-79, Master Plans are under preparation for Aihole-Fattadakal-Badami-Hampi. Martand Awantipur-Pandrethan; Bodhgaya: Fatehpur Sikri and Brajbhumi complexes, etc. Preparation of the microplan for Kushinagar and Sravasti is also being taken up.

### Prices of Tobacco

\*204. SHRI SURENDRA MOHAN: Minister of COMMERCE, Will the CIVIL SUPPLIES AND COOPERA-TION be pleased to state:

However, according to information presently able about actors and actresses, there were 99 actors and actresses from eash of whom income-tax demand exceeding Rs. 10,000 in each were outstanding on 28-2-78. gross amount of income-tax involved in these cases was Rs. 2.26 crores, the corresponding 'net arrear' being Rs. 1.63 crores. A statement showing the amount due from each of them is given in the statement. [See Appendix CVI, Annexure No. 481.

Information in respect of producers and distributors from whom incometax arrears exceeding Rs. 10,000 are due will be collected and laid on the Table of the House as soon as possi-
