Act, if an application in the prescribed form is made, appropriate action will be taken.

This Ministry has no information about the other allegations contained in this report.

Export of Iron Ore

- (a) the targets fixed for iron ore exports for 1977-78 and 1978-79;
- (b) whether these targets have been achieved;
- (c) if not, what are the reasons therefor and what is the extent shortfall: and
- (d) what steps Government are taking to attain the targets?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE. CIVIL SUPPLIES AND COOPERA-TION (SHRI ARIF BEG): (a) to (d) A statement is laid on the Table of the House.

Statement

(a) The target for export of iron ore during 1977-78 and 1978-79 are as under:-

(Quantity: Million Tennes) 1977-78 1978-79 1. M.M.T.C. 14:30 13.20 2. Goan Exporter: . 10.00 10.00 TOTAL 24.30 23.50

- (b) The actual exports of iron ore during 1977-78 were 21.42 million tonnes (12.38 million tonnes M M.T.C. and 9.04 million tonnes by Goan Exporters).
- (c) The shortfall of 2.88 million tonnes in the 1977-78 target was due to heavy inventories with the major foreign buyers of iron ore as a result of continued severe recession in the world steel industry.
- (d) Efforts to locate new markets for diversification of iron ore exports are being made to attain the targets and they have yielded some success.

Loans by the Nationalised Banks to Artisans and Weaker sections of the Society

- (c) if so, what decision Government have taken in the matter?]
