increase the reliability of its services and achieve optimum utilisation of its fleet. It has been able to_raise its vehicle utilisation from 72.58"percent iM July, 1977 to 77.60 per cent in June, 1978. Efforts are being made maintain this trend

I_n the second meeting to "be held in the firsFweek of August, 1978, communal incidents resulting ia breach of peace would be considered.
