Increase in the price of art silk

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (KUMARI ABHA MAITI): (a) A telegram from Punjab Industries Minister was receive^ alleging non-availability of nylon yarn in. Amritsar market. No other memorandum as such was received from Punjab Government

Textile Commissioner held meetings with spinners of nylon yarn t_0 devise means for increasing production and availability of nylon yarn as well as reducing the prices of the same. According to the latest information prices of commonly used deniers of nylon yarn have failed from Rs. 160 per kg. to about Rs. 145 per kg. Deliveries of the nylon yawi to the Amritsar market has been maintained at the steady level of 45 to 50 tonnes per month for the last 2 to 3 years. For the last 3 'months i.e. April—June more than 50 tonnes per month have been delivered to

Amritsar market. The Government is also considering the possibility of operating a buffer stock in respect of 2nd grade nylon yarn.

Price of staple yarn

No other memorandum as such has been received from the Punjab Government,

(b) It has been ascertained from the market reports that though there ha₉ been some rise in the prices of viscos staple yarn, in the month of May it has not been as steep as has been alleged. The rise in prices in the month of May has been about 7 per cent. There have been no reports of scarcity of staple yarn.
