- (b) whether it is also a fact that such abnormal delays in transmission of telegraphic messages have become a regular feature in the Telegraphs Department; and
- (c) if so, what remedial Government have taken to eliminate such delays and to ensure that telegrams reach their destinations within a reasonable time of their actual transmission?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICA-TIONS (SHRI NARHARI PRASAD SUKHDEO SAI): (a) Yes, Sir. The telegram was booked at New Delhi on 27th May, 1978 and delivered to addressee in Calcutta on 31st 1978.

(b) No Sir. However, in certain cases, which are very few. there have been delays in the transmission of telerams.

 - (i) Supervision is being tightened in Telegraph offices to minimise delays and action is being taken against defaulting officials;
 - (ii) Direct outlets are being provided wherever justified to reduce Transit Operations;

and (b) The last round of talks between U.S.A. and U.S.S.R. arms limitations in the Indian Ocean was held in Switzerland in February 1978. Since then, there is no indication when these talks might be resumed. In recent talks with Governments of USA and the Government of India has expressed disappointment at the suspension of these talks and the hope that the talks would be resumed soon and would result in an agreement which could lead to elimination Big Powers military rivalry from Indian Ocean.
