THE MINISTER OF PETROLEUM. CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) Yes, Sir. Some workmen employed at Baroda and Bhatinda Field Offices of Engineers India Limited staged dharna from 18th April, 1978 to 13th May, 1978 at the Registered Office of Engineers India Limited at Parliament Street. New Delhi, against anticipated retrenchment. Five of the workmen on dharna also went on indefinite hunger strike from 1st May. 1978 to 10th May, 1978. The indefinite fast was broken on 10th May, 1978 and the dharna was also unilaterally withdrawn with effect from 13th May, 1978.

(b) None of the workmen employed at Baroda and Bhatinda field offices has so far been retrenched. In accordance with Engineers India Limited's policy they are to be retrenched on the expiry of the period of assignment for the specific project in question. However Engineers India Limited are taking steps to secure alternative employment for them in other undertakings to the extent possible.
