The Betwa River Board (Amendment)

THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): Sir, I beg to move for leave to introducce a Bill to amend the Betwa River Board Act, 1976... (Interruptions)...

MR. CHAIRMAN: Mr. Ranga, if you have any objection to the moving of the Bill, that is a different matter. But if the contents of the Bill are to be discussed, it is not the time. He is only asking for leave to introduce the Bill. Nothing else beyond that.

SHRI N. G. RANGA: I want to object that. According to the Rules of Procedure and also the practice in that House as well as in this House—Members should be allowed to have their say. My objection is this. My hon. friend seems to have done it without a proper sense of responsibility so far as the Food Ministry is concerned.

This Bill deals with the Betwa River-Board (Amendment) Act. So rivers are involved in it. Most of the rivers in Northern India are very angry with us—with the people, with both the political parties and both the Houses of Parliament. Also, unfortunately, millions of people are involved and they are suffering. Hundreds of them have died. Many more may die. Only yesterday the weathermen gave us a wrong picture, saying that in two or three days' time, the floods would recede. We were having our session yesterday...

MR. CHAIRMAN: That is all right. You have had your say.

SHRI N. G. RANGA: The whole of Delhi was under a deluge. I would have expected my hon. friend to take this opportunity to make another statement because, after all, tomorrow the House is not going to be in session... (Interruptions)... While Rome is not burning, Delhi is being flooded and is under a deluge. But he did not say a word about it.

MR. CHAIRMAN: That is all. You have said it.

SHRI N. G. RANGA: He has taken it up just like a civil servant. That is not the way to deal with this House. That is not the way to deal with this crisis. Mr. hon. friend, Shri Ranbir Singh, comes from Haryana. Haryana is in flood. Haryana is crying and dying as a result of it. My hon. friend comes from Punjab. There also some area is under a deluge. I expected him to make a serious, sensible and responsible statement concerning the floods that are overtaking parts of all the States.

MR. CHAIRMAN: You are a senior Member.

SHRI N. G. RANGA: Therefore, since so many hon. Members expressed the wish that this serious question be discussed, I would like my hon. friend first of all to presage it with a statement himself here and now because he must be in possession of the facts. Then the Leader of the House, if necessary, may extend the session of this House by a day or half a day and have a full-dress debate on this particular question.

MR. CHAIRMAN: Now you will have to resume your seat.

SHRI N. G. RANGA: Don't be impatient and close.

MR. CHAIRMAN: You are a senior Member. I will read for your benefit Rule No. 67 because you are unnecessarily taking up the time of the House—your time and my time. It says:—

"If a motion for leave to introduce a Bill is opposed, the Chairman, after permitting if he thinks fit, a brief explanatory statement from the member who moves and from the member who opposes the motion, may, without further debate, put the question:"

You have said enough.

The Bill proposes to accord statutory recognition to the Leaders of Opposition in the two Houses, and provides for the extension of facilities and amenities. that they require for playing their role as-Leaders of Opposition effectively.
