I have to inform Members that I have received a letter from Shri Virendra Kumar Sakhailecha, a Member representing the State of Madhya Pradesh, resigning his seat in the Rajya Sabha. I have accepted his resignation with effect from the 26th June, 1977.

SHRI SWAMI DINESH CHANDRA (Rajasthan): Sir, I want to know whether Shri Bhairon Singh Shekhawat, a Member of this House, has also submitted his resignation or not, because he has been elected as the leader of the ruling party in Rajasthan.

AN HON. MEMBER: He has already taken over there.

MR. DEPUTY CHAIRMAN: We have not received any intimation to that effect up till now.
