approach of the present Board of Directors of M/s. Bird & Co. Ltd. appointed by the Central Government under section 408(1) of the Act. A representation has also been received from Shri Samar Mukherjee, M. P. dated 20-5.77 wherein, besides the above allegation, it has also been pointed out, that the Management had extracted huge amounts by way of sales commission from Titaghur Paper Mills Co. Ltd. for year's together in the name "Lyons Range Agency" till 1974-75.

Government has also received arepresentation of Shri Samar Mukherjee, M.P. dated 4.4.77 and Shri Purna Narayan Sinha, M.P. dated 17.6.77 alleging that by manipulating the Savings Trust, Shri Pran Prasad, who was the Chairman of Bird Heilgers Group till 197,2, had acquired for himself and his family all the assets of Heilgers Sub-Group of companies aggregating to about Rs. 10 crores.

(c) The Company Law Board has considered the matter and passed orders of investigation u/s 237(b) of the Companies Act, 1956 on 30-7-77.

For the passengers on Nainpur-Chhin-dwara-Nagpur section 2 pairs of trains including one pair providing an overnight service is already available.

Classless Trains

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE)": The first train to be introduced before the end of this month with only Second Class accommodation and improved amenities will be the fast intercity train between Madras Egmore and Madurai to be named as Vaigai Express.

Retrenchment of Labourers

*323. SHRI PHANINDRA NATH HANSDA: SHRI BHAIYA RAM MUNDA: SHRI BHAIRAB CHANDRA MAHANTI: SHRI BRAHMANANDA PANDA;

Will the Minister of RAILWAYS be pleased to state whether it is a fact that recently nearly one hundred labourers who were working for the last ten years or more in the Bhadrak-Kapilas Road and Cuttack-Paradip doubling projects have been retrenched; if so, what are the reasons there for?-

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE): On completion of the Cuttack-Paradip New Line Project, 900 casual labour have become surplus. Their retrenchment has become unavoidable, but this is being done in a phased manner to enable as many as possible to get absorbed elsewhere. 100 men were discharged on 1-6.1977 and another 100 on 4-7.1977. The discharged men are encouraged to join **a** Labour Cooperative Society which has been awarded a contract on the nearby Jakhapura-Daitari construction project in the State of Orissa.
