THE MINISTER OF TOURISM ANDCIVIL AVIATION (SHRI PURUSHOTTAM KAUSHIK): Indian Tourism Development Corporation has no plans for the present for the development of tourism in Sikkim due mainly to constraint on resources.

Fraudulent transactions by the Vijaya Bank Limited

Will the Minister of FINANCE AND REVENUE AND BANKING be pleased to state:

- (a) whether it is a fact that a number of fraudulent transactions have been entered into by the Vijaya Bank Ltd.;
- (b) whether it is also a fact that the Reserve Bank of India has its Inspection Report, recommended that the Chairman of $_{
 m the}$ should be removed; and

(c) if so, what action Government propose to take in the matter?

MINISTER OF FINANCE THE AND REVENUE AND BANKING (SHRI H. M. PATEL): (a) The Reserve Bank of India carried out an inspection of the Vijaya Bank Ltd. of the position as it stood on 30th June, 1975 and found several irregularities and undesirable features in the working of the Bank. In February 1977 Incometax Authorities have filed a number of complaints in the Court of the Judicial Magistrate. Mangalore against the Vijaya Bank Limited under Sections 277 and 278 of the Incometax Act, 1961 read with Section 200 Criminal Procedure Code.

- (b) The Reserve Bank has not recommended to the Government or in its Inspection Report the removal of the Chairman of the Vijaya Bank Limited.
- (c) Government have already announced in the Lok Sabha that it is necessary to go into all the facts relating to the Vijaya Bank Limited.

THE MINISTER OF COMMERCE AND CIVIL SUPPLIES AND OPERATION (SHRI MOHAN DHARIA): Consumption of tea in the country during 1977-78 is expected to be about 300 million kgs.
