the Government servant within the members of the family. This includes parents in case there is no nomination. it is payable in the first instance, to the widow, failing her to the eldest surviving son, failing these to the eldest surviving unmarried daughter and failing the above, to the eldest surviving widowed daughter. If there are no surviving members of the family as mentioned above, the family pension can be granted to the father. failing father to the mother. Family pension to the widow stops on marriage. Family pension under this scheme is payable to the parents on production of reasonable proof that they were dependent on the deceased Government servant for support.

- (b) The information called for in this part is relevant only for gratuity and family pension under the Non-Contributory Family Pension Scheme as parents do not form part of family for the purpose of family pension under the Contributory Family Pension Scheme and the General vident Fund Rules. The amount gratuity depends on the length of secvice and emoluments drawn by the Government servant at the time of Ordinarily, Death-cum-Retirement Gratuity is payable at the rate of half a month's emoluments for each completed year of the qualifying service subject to a maximum of 16/1 months emoluments limited to Rs. 30,000/-... As regards the family pension under the Non-Contributory Family Pension Scheme, it is half of the amount of pension admissible to the Government servant depending upon the length of the qualifying service rendered and the emoluments drawn by him subject to a maximum of Rs. 150/-p.m. and a minimum of Rs. 40/--p.m.
- (c) Parents have not been included in the definition of family under the Contributory Family Pension Scheme as this family pension Scheme was measure of social introduced as a security to the immediate dependents of the Government servant. The same consideration applies in the case Provident Fund.

- (a) whether it is a fact that there is no hotel with reasonable amenities in the capital of Manipur as a result of which tourists are put to great in. convenience;
- whether the India (b) Tourism Development Corporation propose to provide financial and other assistance to the private sector for construction of such hotels there: and 510th 1375 -
- (c) if not, what are the reasons therefor and what alternative arrangements Government propose to make to provide accommodation for the tourists at reasonable rates in that city.

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURSHOT-KAUSHIK): (a) At present, no hotel in the capital of Manipur is on the approved list of the Department of Tourism.

(b) and (c) The Indian Tourism Development Corporation does not provide financial assistance to the private sector for the construction of hotels. The Corporation, however, does offer consultancy services on payment basis. As regards financial assistance, the Industrial Finance Corporation of India operates the Hotel Development Loan Scheme for the grant of loans to private sector hotel projects which have been approved by the Department of Tourism as conforming to the prescribed minimum standards. Due to constraint on resources and other Government priorities, it is not possible for the Central Government to construct acommodation at all the places of tourist interest in the country.

C. against Vijaya Bank Ltd., its chairman and Managing Director, Chief Accountant and some other Officers of the Bank, for deliberate omission of various interest payment in the returns made by the Bank under section 285 of the Income-tax Act, 1961 for the financial years 1971-72 to 1974-75.

The complaints were filed on the 9th February, 1977 before the Judicial Magistrate, II Court, Mangalore.
