Reports for Major and Medium irrigation projects are regularly submitted by the State Governments to the Central Water Commission for technical scrutiny of various aspects. The projects are thereafter referred to the Technical Advisory Committee of the Planning Commission for consideration regarding their acceptability for inclusion in the States Developmental Plans. Reports for 322 schemes are, at present, under various stages of technical examination in Central Water Commission. Still more schemes may be received from the States during the remaining part of the year. It is, therefore, not possible at this stage to indicate the number of schemes that may be finally approved by the Planning Commission by the end of this year.]
