will be wrong to leave it only to the Ministry of Health and Family Welfare in the Centre and their counterparts in the States. It is essential that all Ministries and Departments of the Government of India as well as of the States give due importance to this Programme and work for furtherance. The performance Family Welfare in the States will be intensively and carefully monitored and the Union Cabinet will the situation in depth at least once a year. Suitable machinery for ensuring coordination with other connected programmes of welfare may be up in the States also.
