THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SNGH BARNALA): Twenty districts have been presently selected for implementation of I.R.D. programme. So far action plans in respect of Chandrapur district of Maharashtra only have become available from ICAR and the first lot of schemes have been sanctioned and the programme is in the implementation stage in that district.

Resources inventories and Action Plans for the remaining 19 districts are under preparation by the Indian Council of Agricultural Research. As the preparation of Resources Inventories and Action Plans was taking time, State Governments concerned have been advised to indentify programmes for Rural Development for implementation immediate would find place in any programme of Rural Development.

(b) An amount of Rs. 50 lakhs have been spent during 1976-77 on tegrated Rural Development scheme and an amount of Rs. 8 crores have been allocated in Budget Estimates 1977-78 for the scheme.
