against M/s. 'Krishi Udyog' Bombay, their sole selling agents for non-supply of material at a price which the manufacturers/suppliers had contended and at terms and conditions different from those proposed by the Company. On a study it was found by that Commission that the Company is not indulging into any restrictive trade practice."

(d) As per information collected by the Department of Heavy Industries from the Directorate General of Technical Development, the rawmaterial as shown in the Annexure [See Appendix C II, Annexure No. 46] was allotted to the firm for import of steel sheets during the year 1972-73, 1973-74 and 1974-75, for the purpose.

Distribution and Marketing of Fertilisers

462. SHRI SAWAI SINGH SISODIA:

> SHRIMATI LAKSHMI KU-MARI CHUNDAWAT: SHRI PRAKASH MEHROTRA:

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

- (a) whether Government propose to streamline the procedure and machinery for distribution and marketing of fertilisers in the country; and
- (b) if so, what steps Government have so far taken in this regard?

THE MINISTER OF AGRICUL-TURE IRRIGATION (SHRI SURJIT SINGH BARNALA); (a) and Under the Essential Commodities Act. the Government is already regulating the quantities of fertilisers which are to be supplied by the various indigenous manufacturers to different States, Union Territories and Commo-Boards. Simultaneously, the quantities to be supplied out of the stock of imported fertilisers with the Central Government are also determined. In order to assess the requirements of fertilisers of different States,

Union Territories and Commodity Boards, Zonal Conferences are held twice each year before the commencement of each crop season. Besides preparing an allocation plan, an operational review of the distribution and marketing system is also done in these Conferences with a view to further streamlining the marketing and distribution arrangements.

Production and Consumption of Pulses

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

- (a) the total annual production and consumption of pulses in the country during the last three years; and
- (b) the steps which Government propose to take to bridge the gap between the availability of and demand for pulses?

THE MINISTER \mathbf{OF} AGRICUL. TURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): The estimated production of pulses in 1974-75 and 1975-76 is of the order of 10.01 and 13.14 million tonnes pectively. Estimates of production in 1976_77 are not yet available. difficult to give any precise figures of consumption and demand in regard to pulses as this depends on a number of factors like availability of other foodgrains, substitutable foodstuffs, their comparative prices, levels of income, etc.

- (b) Steps are being taken to achieve the productions target of 14 million tonnes of pulses by the end of the Fifth Plan by:—
 - (i) Increasing area under cultivation of short duration varieties of Urd, Moong Cowpea under multiplication cropping; and
 - (ii) Adopting a package of practices aimed at increasing the produc-

inter alia intion of pulses which, the assistance to clude, financial State Governments for laying demonstration of improved cultural practices, production of breeders and foundation seeds of short duration|improved varieties, undertaking plant protection measures, etc. State Governments have also been asked to organise training of extension educating farmers workers for about the improved package practices.

PRATAP CHANDRA CHUNDER): (a) and (b) According to the information furnished by the University Grants Commission, Prof. Dutta was informed that the Institute was part of the Department of Applied Mathematics of the Calcutta University on the basis of recommendations of the Visiting Committee which examined the development proposals of the Calcutta University during the

Fifth Plan period. The Vice-Chancellor of Calcutta University had also in May, 1976 informed the Commission that the relevant authorities of the University had approved the proposal for setting up the Institute as an integral part of the Department of Applied Mathematics.
