Manufacture of Avurvedic and Unani Medicines

436. SHRI MAQSOOD ALI KHAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the capital invested by the Central Government for the manufacture of Ayurvedic and Unani medicines, separately, during each of the last three years;
- (b) the number of new medicines manufactured under each system during the same period; and
- (c) what fresh steps Government propose to take to encourage the manufacture of Unani medicines?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI RAJ NARAIN): (a) An amount of Rs. 2.50 lakhs was allocated each to the Governments of Rajasthan, West Bengal, Uttar Pradesh for the development of State Ayurvedic Pharmacies and herb gardens and Rs. 2.50 lakhs to the Government of Maharasthtra for development of State Ayurvedic and Unani Pharmacy including herbal farm, during 1976-77, under the Centrally Sponsord scheme. While the same amount has been allocated to these States during the current financial year, an amount of Rs. 2.50 lakhs has also been allocated each to the Governments of Andhra Pradesh, Himachal Pradesh, Kerala and Orissa during 1977-78, for development of State Pharmacies and herbal farms. No proposal has been received from any State Government for the development of State Unani Pharmacy separately.

(b) The Central Assistance was paid during 1976-77. The concerned State Governments are in the process of procuring the necessary equipment and its installation for the manufacture of drugs. The actual manufacture of drugs will be known only after the installation of the machinery and the pharmacies going into production.

(c) It has been decided to form a Corporation in Public Sector under the Companies' Act, 1956 for managing a Central Pharmacy of Indian Medicines (including Unani) at Ranikhet.
