(c) A Member of Parliament has recently forwarded a representation. The details are being verified.

## **Eviction of Pong Dam Oustees**

- 539. SHRI F. M. KHAN: Will the Minister of ENERGY be pleased to state:
- (a) the number of Pong Dam oustees from village Dhameta who were sanctioned compensation by the Pong Dam Authority on the 14th October. 1975 and the number of those out of them who actually received compensation money;
- (b) whether the oustees, who have received compensation, have been evicted from their lands; and
  - (c) if not, what are the reasons therefor?
- THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): (a) All the 896 oustees of the village Dhameta have been awarded compensation. Of these 786 oustees had since received compensation.
- (b) Of the 786 oustees, who had received compensation, 722 oustees have been evicted.
- (c) Despite repeated persuasion the remaining persons are residing in the village at their own risk in the hope their houses would not get submerged.

## Apprehension among the Government **Employees Regarding giving evidence** before commissions of inquiry

## THE MINISTER OF HOME AFFAIRS (SHRI CHARAN SINGH): (a) Yes, Sir.

(b) Public servants who had simply acted in compliance with the orders or instructions given to them or who carried them out a little more zeal ously than others have nothing to be afraid of and they need not feel in hibited from sharing with the Com missions any information or know ledge, for fear of indictment or re prisal. Those who had exceeded or misused or abused their powers of authority for securing personal gain or for seeking advantage to other in dividuals) /organisation(s) would, however, attract the critical attention of the Commissions.

Government has written on the above lines to the Ministries/Departments asking them to communicate these views to the officers in the Ministries, attached and subordinate offices and the public sector undertakings. The Saha Commission has also addressed the State Governments and the Union Territories on the same lines.
