(c) Industrial potential surveys of various districts have been conducted by the small Industries Development Organisation, Assam Government, North-Eastern Industries & Technical Consultancy Organisation, Industrial Development Bank of India, (Jointly with other financial institutions) and National Industrial Development Corporation.

68 cases have been recommended by the State Government for issue of licences and letters of intent for setting up industries in backward and tribal areas in Assam from 1970 to June, 1977.

Will the PRIME MINISTER be pleased to state:

- (a) the number of D.T.C. buses or the sick list at present lying in the various workshops of the Delhi Transport Corporation;
- (b) whether it is a fact that these buses require only minor repairs; and
- (c) what steps Government propose to take to make these buses road worthy at an early date?

THE PRIME MINISTER (SHRI MORARJI R. DESAI): (a) 468 buses were held-up for major repairs in the workshop of the Corporation as on 1-7-1977.

- (b) No, Sir.
- (c) The repairs have been held up because of shortage of spare parts and other materials required for repairs. Arrangements are being made for quick procurement of these spare

parts and materials. The DTC has been asked to ensure repairs of at least 320 buses by the end of December, 1977.

## Review of Production Performance

- (a) whether a meeting of the chief executives of public sector undertakings under his Ministry was convened in the early part of the year to review the production performance of these undertakings and to discuss steps to be taken for increasing the production in these units; and
- (b) if so, what are the details in this regard?

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) and (b) A meeting of the Chief Executives of Public Sector Undertakings under the Department of Industrial Development was held in New Delhi, under the Chairmanship of Minister of Industry on the 6th April, 1977. The meeting reviewed the performance of 1976-77 and fixed targets for 1977-78.

The production of 11 Industrial Undertakings during 1976-77 was Rs. 123.03 crores. A target of Rs. 142 crores has been fixed for the year 1977-78.

- (a) whether Government have decided to allow monopoly houses and multinational corporations to maintain their present size of operations; and
- (b) if so, what are the details in this regard?

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) and (b) A statement is laid on the Table of the House.

## Statement

(a) and (b) Activities of 'monopopolistic undertakings' as defined in the Monopolies and Restrictive Trade Practices Act are regulated through the provisions of the said Act. Similarly, activities of companies having non-resident interest above 40 per cent are goverened by relevant provisions of the Foriegn Exchange Regulations Act. 1973. The industrial undertakings belonging to either of the categories mentioned above and coming within the purview of the provisions of Industries (Development ond Regulation) Act are also regulated by its visions. These undertakings are subject to the discipline of industria! licensing and no exemptions from industrial licensing are admissible to them.

The existing policy permits foreign companies and the undertaking covered by the provisions of the Monopolies and Restrictive Trade Practices Act to enter only in 19 specified industries which are of importance to the national economy or have direct linkages with such industries, or have a long-term export potential. Even in these categories of industires, Governments policy is to encourage competent small and medium entreprethese categories of industries, Govforein companies and MRTP undertakings. The objective of the Government is to ensure that operations of foreign companies and MRTP undertakings including monopilistic undertakings conform to the overall socioeconomic policy of the Government and their activities including their size of operations are regulated within the policy guidelines announced by Government from time to time.

## Central Minister's visit to Gujarat

(b) and (c) A total expenditure of Rs. 24,226,42 was incurred by way of travel expenses, etc., of these Ministers. Out of this, a sum of Rs. 17,818.57 represented the cost of travel by IAF air-craft for private visits of Ministers to Gujarat and the balance of Rs. 6,407.85 was in connection with their official duties. A recovery of Rs. 17,818.57 on account of private visits of Ministers was made from the All India Congress Committee.

An expenditure of Rs. 27,041.22 was incurred on the personal staff who had accompanied the Ministers on their tours to Gujarat. No recoveries were effected on this account.
