Safeguards for Telephone System during Monsoons

Will the Minister of COMMUNI-CATIONS be pleased to state what steps Government have taken or propose to take against deterioration in or break-down of telephone system in Delhi during the Monsoons?

THE MINISTER OF COMMUNICATIONS (SHRI BRIJ LAL VERMA): Telephones go out of order * during monsoons mainly due to extensive damages caused to underground telephone cables by large scale road digging operations undertaken by various service organisations during the premonsoon dry season. Such damages do not normally cause failure of the telephone service during the dry season, but result in faults on the onset of the rainy season with the ingress of moisture into the damaged cables, some of which carry 1000 and 1200 telephone lines.

Special steps being taken to minimise the adverse effect of this situation are:

- (a) Progressive Gas Pressurisation of underground inter-exchange junctions and main telephone cables. About 615 Km of underground cables have been pressurised.
- (b) Progressive use of jelly filled cables;
- (c) Gradual replacement of overhead wire alignments by underground cables;

- (d) Systematic checking of junc tion circuits including indoor equipments;
- (e) Progressive systematic check of subscriber fittings and gradual replacement of old fittings;
- (f) Progressive use of ducts for laying cables under some of the major roads.
