(d) whether Government propose to reorganise the Telephone Department of Calcutta with a view to improving its working?

THE MINISTER OF COMMUNI-(SHRI BRIJ CATIONS VERMA): (a) and (b) News which appeared in the Calcutta Daily about the Calcutta Telephone System was taken note of. Due to large scale digging of roads of the cities of Calcutta and Howrah by different service organisations, the underground cables of Calcutta Telephone system got damaged extensively during the pre-monsoon dry season. Such damages do not cause failure of the telephone service during the dry season but result in faults on the onset of the rainy season with the ingress of moisture into the damaged cables. The water logging of main roads and restricted working on main roads due to heavy traffic also delays restoration work.

- (c) So far about 200 Kilometers out of 1000 kilometers of junction cables have been gas pressurised. More length will be taken up for pressurisation soon after the monsoon.
- (d) Re-organisation of the administrative set up of the Calcutta Telephone District was recently completed with decentralised areas under the charge of six Area Managers. sides, a Committee of Senior nical Experts has also been set up to go into such aspects as organisational structure, procedures of work, tems of forecasting and prospective planning necessary for efficient functioning of the four metropolitan districts.
