†[THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE):
(a) The present policy for the award of bookstall contracts at railway stations is that all fresh allotments of bookstalls will be given to individual unemployed graduates within the age group 18 to 30 years, their partner-

- ships, associations and cooperatives, at-
- (i) stations where there is no bookstall at present but a bookstall may be considered necessary in future;
- (ii) new stations which may be opened in future; and
- (iii) new platforms added after 1-1-1976 to existing stations, even where there is already a bookstall contractor.
- (b) The terms of reference of the committee under the Chairmanship of Shri Parimal Ghosh did not cover allotment of bookstalls and as such no recommendation was made by the said committee on this subject.]

Vacancies of Judges in High Courts

- 30. SHRI S. W. DHABE: Will the Minister of LAW, JUSTICE AND COMPANY AFFAIRS be pleased to refer to the answer to Starred Question 68 given in the Rajya Sabha on the 11th April, 1977 and state:
- (a) whether the Central Government have received proposals regarding filling up of vacancies of Judges in High Courts from the State Government's from whom such proposals were awaited;
- (b) whether Government propose to simplify the procedure for appointment of High Court Judges to facilitate early filling up of these vacancies; and
- (c) whether Government propose to appoint persons from the legal profession and eminent jurists as High Court Judges in view of the fact that very few appointments were made from these categories during the last five years?

THE MINISTER OF EDUCATION SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): (a) The Government of India have since received a few proposals.
