Reservation for Persons belonging to the Scheduled Castes Scheduled Tribes in the Cadre of Superintendent of Customs (Preventive) in the Cochin Custom House

- (b) what is the number of posts in the above Cadre to which persons belonging to the Scheduled Castes Scheduled Tribes have been promoted;
- (c) whether any such promotees have been reverted from the post of Superintendent of Customs (Preventive) in the Cochin Custom House on the 15th July, 1976; and
- (d) if so, what are the reasons for their reversion?

THE MINISTER OF FINANCE AND REVENUE AND BANKING (SHRI H M. PATEL): (a) The directive contained in the Department of Personnel Office Memorandum dated the 27th November, 1972 is applicable only to promotions which are made on the basis of seniority-cum-fitness. posts of Superintendents of Customs (Preventive) are filled by promotion on the basis of selection and the orders applicable are those contained in the Department of Personnel Office Memorandum dated the 20th July, 1974. The latter instructions have been strictly followed in respect of the cadre of Superintendent of Customs (Preventive) of the Cochin Custom House.
