lowest price at which wheat was sold in some important Mandis of these States, Manci-wise; and

(c) what are the reasons for which the Food Corporation of India did not purchase the wheat offered by the farmers in these Mandis?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI PARKASH SINGH BADAL): (a) As far as Government are aware there has been no case in Punjab and Haryana Mandis where farmers have sold wheat conforming to specifications laid down by the Government below the procurement price.

(b) and (c) Do not arise.

SETTING UP OF WINE SHOPS NEAR TEM-PLES, HOSPITALS AND RESIDENTIAL AREAS

117. SHRI MAQSOOD ALI KHAN: Will the Minister of EDUCATION, SO-CIAL WELFARE AND CULTURE be pleased to state:

- (a) whether Government's attention has been drawn to the fact that some wine shops are located near temples, hospitals and residential areas in certain towns of Haryana;
- (b) whether Government have also received complaints in this regard; and
- (c) if the answer to parts (a) and (b) above be in the affirmative, what action Government have taken or propose to take to remove these shops from such areas?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER):
(a) and (b) According to the guidelines issued to the State Governments, no liquor shops are to be allowed along residential areas in towns and villages or anywhere near educational institutions, religious places and colonies of labourers. The Government of India, Department of Social Welfare has not received any complaint of location of wine shops near such institutions/areas.

(c) Does not arise.
