SOCIAL AND ADULT EDUCATION

195. SHRI BAPURAOJI MARO-TRAOJI DESHMUKH : Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state :

(a) the steps taken by Government during the last three years for social and adult education; and

(b) the extent to which the State Governments have implemented the Central Schemes in this regard.

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): (a) During the last three years, the

Government has continued on-going programmes and has launched new programmes in the field of adult education as indicated below :—

ON-GOING PROGRAMMES

(1) Farmers Functional Literacy Project;

(2) (i) Preparation of Literature for Neo-Literates by giving Grants to States for the production of literature for neo-literates;

(ii) Prize Competition of manuscripts for neo-literates; and

(iii) Supply of follow-up literature for neo-literates.

- (3) Workers'—Social Education Institutes;
- (4) Polyvalent Adult Education Centres (Shramik Vidyapeeths) for urban industrial workers;
- (5) Assistance to Voluntary Organisations working in the field of adult/non formal education.

NEW PROGRAMMES

- (6) Non-Formal Education for the age-group 15-25; and
 - (7) Functional Literacy for Adult Women in the age-group 15-45.
- (b) Programmes mentioned at 1, 2(i), 6 and 7 above are being implemented through and with the help of State Governments. Generally speaking, they have cooperated in implementing these programmes.
