**THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND REHABILITATION (SHRI SIKANDAR BAKHT):**

(a) Yes, Sir. Orders of Government were issued on 16th February, 1977. A High Level Implementation Body with the Lt. Governor as Chairman has also been set up on 2nd May, 1977 to watch the progress of regularisation and development of unauthorised colonies.

(b) Regularisation of unauthorised colonies will be done in accordance with the terms and conditions stipulated and subject to change of land use on merits being effected.

(c) No decision has yet been taken in this regard.

(a) and (b) Water Supply to Kalkaji and other adjoining areas is checked daily, from source to distribution in the laboratory of the Delhi Water Supply and Sewage Disposal Undertaking. The supply is satisfactory, both chemically and bacteriologically, with adequate residual chlorine as a safeguard against contamination. The question of taking any other remedial steps does not arise.
