On the basis of a techno-economic survey conducted in respect of these 3 new projects with regard to identifying the extent of local raw materials, resources in skilled labour, artisans etc., appropriate technology, existing level of industrial development and potential for development of small scale and cottage industries, the

actual operation of the programme has been taken up from 1974-75.

Central financial assistance amounting to Rs. 189.37 lakhs has been released to Karnataka State Govt. for the implementation of the RIP Programme from the year 1962-63 to 1976-77. The details are given below:

THE MINISTER OF INDUSTRY (SHRI BRIJ LAL VERMA): (a) Five Rural Industries Projects in respect of some selected blocks in the districts of Saharan-pur, Ghazipur, Jhansi, Allahabad and Almora were initiated in 1962-63. The Rural areas of Lucknow District were taken up under this programme in 1971-72. The areas of operation of the earlier five Projects was extended to cover the entire districts except towns with more than 15,000 population according to 1961

census. 7 more District Projects covering the rural areas of the districts of Mathura, Rai Bareli, Fatehpur, Balia, Deoria, Moradabad and Unnao were sanctioned towards the end of the 4th Plan. On the basis of a technoeconomic survey conducted in respect of these 7 projects with regard to identifying the extent of local raw materials, resources in skilled labour, artisans etc. appropriate technology, existing level of industrial development and poten-

tial for development of small scale and cottage industries, the actual operation of the programme has been taken up from 1974-75.

Central financial assistance amounting to Rs. 377.98 lakhs has been released to the U.P. State Government for the implementation of the Rural Industries Projects Programme from the year 1962-63 to 1976-77. The details are given below :—

POWER SHORTAGE IN WEST BENGAL

- 277 SHRI SARDAR AMJAD ALI : Will the Minister of ENERGY be pleased to state :
- (a) whether Government are aware of the acute power crisis in West Bengal;
 - (b) if so, what are the causes thereof; and

(c) what steps Government have taken to improve the situation ?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): (a) and (b) Yes, Sir. West Bengal has been having capacity shortage to meet peak demand. The position in May '77 was particularly aggravated by the fact that a number of thermal generating units were under planned and forced outages. The situation became worse on 22-5-1977 and again on 27-5-1977 due to tripping of Santaldih-Howrah 220 KV line resulting in stoppage of flow of power from Santaldih to Howrah

- (c) The following steps have been taken:
- (i) The 220 KV Santaldih-Howrah line has been recommissioned;
- (ii) The State Electricity Board and D.V.C. are taking steps to expedite the recommissioning of thermal generating units under forced and planned outage;
- (iii) The power from existing thermal generating units is being maximised by improving their performance;
- (iv) The commissioning of 3rd 120 MW unit at Santaldih Thermal Power Station which is due to be commissioned during this year is being expedited.
