MANUFACTURE OF COMPUTERS BY MULTI-NATIONAL COMPANIES

*92. SHRI JAGJIT SINGH ANAND : SHRI INDRADEEP SINHA : DR. Z. A. AHMAD :

Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that some multi national companies have recently sought permission to start manufacture of com puters in the country; and
- (b) if so, what are the details in this regard?

THE PRIME MINISTER (SHRI MORARJI R. DESAI): (a) and (b) International Computers Limited (U.K.), have a wholly owned subsidiary called ICL (India), as also a company called International Computers Indian Manufacture (ICIM) Ltd., in which ICL (U.K.) hold 60% of the equity. ICL have agreed, in response to the requirements of Foreign Exchange Regulation Act, to wind up the operations of ICL (India) and to dilute the foreign equity in ICIM Ltd. to 40%. They have proposed manufacture of the new range of ICL 2904 computers by ICIM Ltd. with a foreign equity of 40%. Their application for a manufacturing licence is under consideration of the Project Approval Board.

NEW INDUSTRIAL POLICY

THE MINISTER OF INDUSTRY (SHRI BRIJ TAL VERMA): (a) and (b) The basic features of the industrial policy

of the new Government relate to the objective of generating maximum possible employment in the industrial sector leading to optimum socio-economic benefits in the circumstances obtaining in our country and the decentralisation of economic power through strengthening the cottage and small scale industries based on the use of appropriate technologies. Operational details of the new industrial policy would be worked out in due course of time.

LEGISLATION TO PREVENT DEFECTIONS IN LEGISLATURES

- (b) if so, whether Government will keep in view the recommendations of the Committee on Defections in this connection; and
- (c) by when the proposed Bill is likely to be introduced in Parliament?

THE MINISTER OF HOME AFFAIRS (SHRI CHARAN SINGH): (a) and (c) The Government propose to bring forward in the current session of Parliament suitable legislation to curb defections.

(b) Yes, Sir.

SUPPER OIL TANKER TERMINAL AT COCHIN

*101. SHRI PATTIAM RAJAN : SHRI P. K. KUNJACHEN :

Will the PRIME MINISTER be pleased to state :

(a) the progress so far made in regard to the proposal to construct a Super Oil Tanker Berth at Cochin:

- (b) whether it is a fact that the development plans for the Cochin Port could not be executed as the same were linked with this project with the result that allocations for such developments during the Fourth and Fifth Five Year Plan periods have largely remained unutilised; and
- (c) if so, whether Government propose to take an early decision in the matter?

THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM): (a) An investment decision on the Super Tanker Oil Terminal at Cochin would depend on the feasibility of processing Bombay High crude in the Cochin Refineries. This question is at present under examination.

(b) and (c) The Port had a proposal for an improved facility for handling fertilizers taking advantage of the deeper draughts which were to be created in connection with the Super Tanker Oil Terminal. As no final decision on the Oil Terminal has been taken, alternative arrangements have been made for handling fertilisers by suitable modifications to the existing berths. No other specific development plans of the Port were linked with the Oil Terminal project.
